

Resolution of the Village Board of Trustees of the Village of East Nassau
Adoption of Local Law No. 1 of 2023

At the monthly meeting of the Village Board of Trustees of the Village of East Nassau (the “Village Board”), duly held on the 9th day of August, 2023, the following Resolution was presented:

WHEREAS, the Village Board has been informed that the recent amendment to the Real Property Tax Law allows local governments to provide a real property tax exemption for individuals who serve as volunteer firefighters and ambulance workers; and

WHEREAS, the Village Board recognizes the invaluable public service these volunteer first responders perform and the dedication they have to volunteer their time for such service; and

WHEREAS, given that the State has provided such authority for the first time and in recognition of these individuals as well as to encourage others to volunteer, the Village Board desires to make available such exemptions; and

WHEREAS, counsel for the Village prepared a proposed Village Local Law (introductory Local Law No. 1 of 2023) for such purpose and the proposed law has been reviewed and revised by the Mayor and discussed by the Village Board at a meeting of the Village Board;

WHEREAS, the Village Board scheduled a public hearing on Introductory Local Law No. 1 of 2023 and said hearing was duly held on August 9, 2023 at which the public had an opportunity to make comments on said Law: and

WHEREAS, the hearing has been closed by the Village Board which is now prepared to act on the proposed law:

NOW, THEREFORE, BE IT RESOLVED as follows:

1. The public hearing on proposed Local Law No. 1 of 2023 has been duly held and closed and those who wished to be heard regarding said proposed law had a full and fair opportunity to be heard. The Village Board has considered all comments made.
2. The Village Board has previously determined that the adoption of the proposed Local Law is a Type 2 action under the State Environmental Quality Review Act (SEQRA) and no SEQRA review is required.
3. The Village Board hereby adopts Local Law No. 1 of 2023 of the Village of East Nassau, entitled, “Volunteer Firefighter and Volunteer Ambulance Workers Real Property Tax Exemption.”

4. The Village Board hereby directs that the Village Clerk prepare said Law for filing and that it be filed with the Office of the Secretary of State.
5. This Resolution shall take effect immediately.

Upon motion made by Trustee Thomas Kernan, seconded by Trustee Gerald Tremblay, the foregoing Resolution was duly adopted by the Village Board of the Village of East Nassau on August 9, 2023 by vote of a majority of its members as follows:
